NOTICE OF A PUBLIC HEARING ON
THE PROPOSED BUDGET AND PROPOSED TAX LEVIES FOR
THE CITY OF PASCAGOULA, MISSISSIPPI

The City of Pascagoula will hold a public hearing on its proposed budget and proposed tax levies for fiscal year 2020 on September 5, 2019 at 6:00 p.m. at Pascagoula City Hall, 603 Watts Avenue.

The City of Pascagoula is now operating with projected total budget revenue of \$48,923,555. Twenty-Six percent (26%) or \$12,724,018, of such revenue is obtained through ad valorem taxes. For next fiscal year, the proposed budget has total projected revenue of \$40,374,870. Of that amount, Twenty-Nine Percent (29%) or \$12,046,369 is proposed to be financed through a total ad valorem tax levy.

The decision not to increase the ad valorem tax millage rate for fiscal year 2020 above the current fiscal year's ad valorem tax millage rate means you will not pay more in ad valorem taxes on your home, automobile tag, utilities, business fixtures, and equipment and rental real property, unless the assessed value of your property has increased for fiscal year 2020.

Any citizen of the City of Pascagoula, Mississippi, is invited to attend this public hearing on the proposed budget and proposed tax levies for fiscal year 2020, and will be allowed to speak for a reasonable amount of time and offer tangible evidence before any vote is taken.
