**RESOLUTION OF THE CITY OF PASCAGOULA, MISSISSIPPI
APPROVING USE OF CITY PROPERTY AND RESOURCES
REGARDING DELIVERY OF RELIEF SUPPLIES TO LEAGUE CITY, TEXAS**

WHEREAS, on September 5, 2017, the City Council of Pascagoula officially proclaimed the City of League City, Texas, a sister city with Pascagoula and offered assistance to League City in its recovery and rebuilding process following landfall of Hurricane Harvey; and

WHEREAS, the City of Pascagoula received nearly fifty-five (55) pallets of relief supplies to the City of League City and will deliver the supplies to League City on September 15, 2017; and

WHEREAS, the use of City personnel and property are being called upon to assist in delivery of the relief supplies to the City of League City on September 15, 2017; and

WHEREAS, the City Council finds that the participation of City personnel and use of City property in the delivery of relief supplies to the City of League City on September 15, 2017 is a way of advertising and bringing into favorable notice the opportunities, possibilities and resources of the City; and

NOW, THEREFORE, BE IT RESOLVED AS FOLLOWS:

SECTION 1: That the City Manager of Pascagoula is authorized and directed, in his discretion, to assign City personnel and property to assist in delivery of the relief supplies to the City of League City on September 15, 2017.

SECTION 2: That the City Manager of Pascagoula, in his discretion, is also authorized to allow the use of City resources for this effort, and as a means of advertising the resources of the City.
