Mayor Maxwell stated this meeting was for a presentation of the Police Department and Parks and Recreation Department FY 2017-18 budget. The MS Maritime Museum did a presentation and request for the City's support of the Museum.

Jack Hoover, Campaign General Chairman of Capital Campaign, addressed the Council to present the status report of the Mississippi Maritime Museum and to ask for support from the City for Phase 2 of this project. Mr. Robert Harvey, Treasurer, reported that Phase 1 is complete and Phase 2 will begin with the renovation of the Math and Science Building and will house the exhibits to include interactive exhibits. The estimated cost of Phase 2 is \$4.75 million. They are asking the City for consideration of pledging \$250,000 for the first year and \$50,000.00 over the next 4 years and will keep the City informed on the progress that is made during the renovation. Mayor Maxwell thanked Mr. Hoover and Mr. Harvey for their presentation.
