14th Street Drop Off Center (located next to the Building Department, 4015 14th St.)

Open Monday thru Friday 8:00 A.M. till 4:00 P.M. Will accept yard waste, white goods, and bulky waste. No construction material, tires, batteries, electronic waste, or food waste will be accepted.

ATTENTION: CONTRACTORS, LANDLORDS AND RESIDENTS

The Solid Waste Department needs your assistance with keeping the City curbs clean.

By adhering to the City Ordinances, we have increased enforcement action in an attempt to prevent waste problems on the City curbs.

Curbside cleanliness is directly linked to:

- Clogged storm drains, which leads to street flooding and pollution to our streams and the Gulf.
- Poor neighborhood aesthetics which leads to lower property value.
- Increased crime rate in some areas.

Environmental Compliance Division Officers will aggressively pursue parties that pollute City right-of-ways with waste that does not conform to City Ordinances.



City Ordinance Sec. 70-11. Materials not to be collected by City

(b.) Building materials. Building material resulting from construction, demolition, repairs, or remodeling of any building or structure.

(c.) Tree Trimmings. Tree trimmings produced by tree surgeons, landscape or tree service contractors, pulp wood cutters or other commercial worker.

The items listed above shall be the duty and responsibility of contractors or property owner for the removal and proper disposal of such materials.

City Ordinance Sec. 70-3. Refuse to be drained of liquids: Placement of bulky items; hazardous waste.

(a.) Refuse shall be drained of all liquids and deposited in containers. Bulky items, such as furniture, appliances, yard toys and unbundled or uncontainerized tree trimming shall be placed at roadway with trash container.

(b.) Hazardous waste shall not be collected by the City nor shall such waste be placed in containers for collection by the City. Contact Environmental Compliance at 475-6322 for assistance in the proper disposal of hazardous waste.

Hazardous waste may be disposed of during 'Household Hazardous Waste Day Events'. This event is conducted by Jackson County Solid Waste (872-8340).

City Ordinance Sec. 70-8. Depositing upon public property, or on premises or in containers of another.

(b.) It shall be unlawful for any person to place or deposit any refuse or litter upon the property of another person or upon a street, alley, park, or other public property, or in any canal, waterway, pool or the like, or in any container upon which another person has paid the collection fee.
