Owner's General Description of Project: Improvements to I.G. Levy Park to include the installation of a concrete basketball court and sidewalks, as well as lighting upgrades to be provided by Singing River Electric.

**DETAILED SCOPE OF WORK, SCHEDULE AND COST:**

Consultant to provide detailed proposed scope of work, with any applicable associated milestones, dates, and costs associated with phases of work:

Proposed Scope of Work:

1. CE shall provide topographical survey services at I.G. Levy Park for use in design.
2. CE shall provide design services to prepare bid documents to acquire bids one time for a contractor to install a concrete basketball court and associated sidewalks at the I.G. Levy Park in Pascagoula. Additionally, CE will coordinate with Singing River Electric for the installation of new lighting to support the proposed basketball court.
3. CE shall provide services during construction to include construction administration and construction observation for the installation of the proposed improvements.

Timeline and Milestones: CE will begin work within 7 days of receipt of an executed Task Order. CE will complete the proposed bid documents within 60 calendar days thereafter.

Cost and Method of Compensation (Lump Sum or Hourly Rates):

1. CE shall provide the survey services as described in Item 1 above for a lump sum fee of \$1,000.00.
2. CE shall provide the design services as described in Item 2 above for a lump sum fee of \$7,500.00.
3. CE shall provide the services during construction as described in Item 3 above for a lump sum fee of \$7,000.00.
