Are you 13-15 years old and like would like to spend time with children as we re-create the magic of summer?

Apply to become a counselor in training with the City of Pascagoula Summer Camp '15. Camp will be held at TBD from 7:00 am-5:30 pm, Monday-Friday.

Assisting experienced camp counselors at our day camp for children ages 6-12 will help you gain leadership skills-while having fun and learning more about what summer excitement is all about. Counselors in Training (CITs) will play an important role in the success of our day camps. They will help the counselors implement their lessons plans and act as role models for the campers.

Summer Day Camp is held in June and July of each year. There is a limit of six CITs accepted into the counselors in training program. All counselors must work at least 30 hrs per week.

REGISTRATION PROCEDURES please complete the application and mail, fax, or bring it to our office. The tuition fee is \$350 per summer for Pascagoula Residents and \$440 for non residents and must be paid one week after being notified of your selection for Counselor in Training (Payment arrangements can be made if needed). All applications must be received by May 5, 2015.

INTERVIEW/TRAINING/ WITHDRAWAL PROCESS Once your application is received an interview will be scheduled. It is at this time that evaluation and selection is made by the Camp Administrators. If you go through Staff Training and then decide not to participate in the program then the cost of early withdrawal from the program is 65% of the fee. Should you participate in the camp program and be dismissed from the program there will be no refund of the tuition.

Complete participation at Staff Training is MANDATORY for acceptance into the program. Please refrain from asking us to make an exception for you. Pascagoula Recreation is proud of the fact that we provide the highest quality professionally trained staff and you will become part of that staff.
